

Minutes of the meeting of Sandleheath Parish Council (SPC) held on Thursday, 22nd June 2017 at 7.30pm at St Aldhelm's.

Also in attendance were 2 residents.

17.102 To receive apologies for absence: Apologies were received from Parish Cllrs Wright and Mrs V Eden (Clerk).

17.103 To receive any declarations of interest by any councillor on any agenda item: None.

17.104 To approve and sign the minutes of the meetings held on 25th May 2017 (Parish Council Annual Meeting) and 8th June 2017 (Special Meeting). Following an amendment made by the Clerk to the amount in the current account (the figure was amended to reflect that the cheque made payable to HALC for £24 in March 2017 had been cashed as at the time of the meeting) and alterations to the meeting dates in 2018 (to read 2018), in the previously forwarded minutes, it was proposed and seconded and, following an unanimous vote, therefore **RESOLVED** that the updated minutes of the meeting held on 25th May 2017 be signed as a true record. It was proposed and seconded and, following an unanimous vote, therefore **RESOLVED** that the minutes of the meeting held on 8th June 2017 be signed as a true record.

17.105 Public Session: The Chairman provided a brief overview to the agenda items.

17.106 Reports by County and District Councillors: Not present.

17.107 Matters to Report:

- The request to adopt the public telephone box has now been cancelled.
- Joint letter from the SCA and Parish Council requesting volunteers has now been forwarded to each household in Sandleheath. This had proved successful and the Sandleheath fete was held on 17th June 2017, raising funds for community use.

17.108 The Common:

- 1) Emergency Access procedure James Knight, Civil Contingencies and CCTV Manager at NFDC, has advised that he is happy with the draft procedure and is liaising with his team. Once final confirmation is received, signage will be organised accordingly.
- 2) A query from a resident relating to overhanging trees had previously been forwarded to councillors, together with details of previous action undertaken by the parish council in 2001. Following discussion it was agreed that Cllr Stockton would draft a email stating that the council did not own the trees, had no objection to them being pruned, but that the landowner must be contacted to obtain permission.
- 3) Planting of new trees on the Common The Chairman and a resident had looked into the replanting of trees on the Common and suggestions were discussed. It was agreed that 3 trees would be purchased (up to a value of £200) and planted in the proposed locations (position C to be relocated to accommodate the bonfire). Cllr Stockton would chose three different types of tree.
- 4) Any other concerns none raised.

17.109 Highways/Footpaths

- 1) A request to formally name Bishops Lane had now been forwarded to and acknowledged by NFDC. Ongoing progress to be reported at the next meeting.
- 2) Update in relation to ongoing repairs to highways the water leak had now been fixed and a pothole would be reported on Hantsweb for repair.

3) Update in relation to any issues with footpaths/cyclepath - No further update received from Esther Smeardon in relation to the cyclepath (with regard to installation of stiles/gates and additional culverts).

17.110 Future of St Aldhelm's: Cllr Daykin provided a short update – a formal complaint has been made to the Solicitors with regard to lack of progress and increasing costs, the presence of Japanese Knotweed on site was also re-stated.

Parish Lengthsman Scheme: The next visit is on 7th August 2017 and members 17.111 were advised to forward any new tasks to Cllr Stockton. Fordingbridge Town Council had notified parishes that additional dates were available and Cllr Stockton agreed to prepare a worksheet with tasks agreed at the meeting.
